**It's 8:30 a.m.** and Andy Rossetti is meeting with an engineering expert in a products liability case that caused his client to be ejected from her delivery van after a car crash. The easy case was against the other driver, but there was little insurance coverage and Rossetti was driven to find out why his seriously injured client was ejected from a van that essentially ripped apart in a lowspeed collision. Rossetti's instincts were right—he eventually uncovered that the manufacturer failed to follow its own specifications in welding the body of the van, causing it to rip apart on impact. The result was a huge, multi-million dollar settlement.

Across town, Lou DeVoto is in court getting ready to question his expert in a medical malpractice case that caused his client to be negligently discharged from a South Jersey emergency room. At trial, DeVoto uncovered medical mistakes that led to the erroneous

discharge rather than an admission for immediate treatment. The result: a large jury verdict for his injured client.

Dealing with such traumatic experiences can be trying, but De-Voto says it is their business to make sure clients are taken care of. "Clients are always emotional when something traumatic happens to them," he says. "It's a difficult time in their life, for sure.
